### Funding Options

The Texas Education Agency administers billions of dollars in both state and federal funds that support a variety of programs to benefit public education. Funds come from multiple sources, including state and federal coffers, federal grants, the Permanent School Fund endowment, and others.

The content of this document is intended to:

1. Provide general information and guidance to Texas local education agencies (LEAs). This is not a comprehensive guide for all sources of fundings. Please visit [tea.texas.gov](http://tea.texas.gov) for a full list of financial compliance regulations and remember to adhere to local policies and procedures. If you aren't sure what to do, look it up or ask. ***This document does not constitute legal advice.***

<b>ESSA:</b> Every Student Succeeds Act	<i>Replaces No Child Left Behind (NCLB) and reauthorizes the 50-year-old Elementary and Secondary Education Act (ESEA), the nation's national education law and longstanding commitment to equal opportunity for all students.</i>	<p><b>ESSA Highlights:</b></p> <ul style="list-style-type: none"> <li>Advances equity by upholding critical protections for America's disadvantaged and high-need students.</li> <li>Requires that all students in America be taught to high academic standards that will prepare them to succeed in college and careers.</li> <li>Ensures that vital information is provided to educators, families, students, and communities through annual statewide assessments that measure students' progress toward those high standards.</li> <li>Helps to support and grow local innovations</li> <li>Sustains and expands increasing access to high-quality preschool.</li> <li>Maintains an expectation that there will be accountability and action to effect positive change in our lowest-performing schools, where groups of students are not making progress, and where graduation rates are low over extended periods.</li> </ul> <p>To receive federal funding for State Education Agencies, consolidated ESSA State Plans had to be created and submitted to the U.S. Department of Education by September 25th, 2017. Amendments, addendums, and waivers are submitted periodically and are posted on <a href="#">TEA's ESSA page linked here.</a></p> <p><b><i>The ESSA consolidated state plan for Texas includes: Title I, Parts A, C, D; Title II, Part A; Title III, Part A; Title IV, Parts A, B; and Title V, Part B; Title VII, Subpart B of the McKinney-Vento Act</i></b></p>	<a href="#"><u><b>Every Student Succeeds Act: Final Consolidated State Plan for Texas</b></u></a>	TxSP Counseling Section provides a step-by-step process, starting in 8 <sup>th</sup> grade to ensure all students graduate on time or have an alternative plan. The process is a closely monitored system that monitors credits, grades, attendance, and behavior and provides interventions before the gaps grow too large.

<b>Title I, Part A:</b> Improving Basic Programs Operated by Local Educational Agencies	<i>Provides supplemental funding to state and local educational agencies to acquire additional education resources at schools serving high concentrations of students from low-income homes.</i>	<p>Title I funds ARE NOT required to be used only for specific academic subjects.</p> <p>Title I funds ARE NOT limited only to instructional costs such as teachers. According to federal law, Title I funds can be used for non-instructional costs like behavior supports, attendance programs, community/parent engagement if these costs are shown to help improve student outcomes.</p> <p>Title I funds CAN be spent on comprehensive, school-wide interventions.</p> <p><b>Questions to ask:</b></p> <ul style="list-style-type: none"> <li>• Does the program drive improved results for students?</li> <li>• Will the program increase the capacity to improve results for Title I schools?</li> <li>• Will the program accelerate federal guidelines for school improvement?</li> <li>• Will the program avoid recurring costs once the funding ends?</li> <li>• Will the program create feedback loops that offer continuous improvement opportunities?</li> </ul> <p><b>Assurances Relating to Comparability of Services</b>  <i>An LEA may receive funds under Title I, Part A, and Title I, Part C, (MEP) only if state and local funds will be used in participating schools to provide services that, taken as a whole, are at least comparable to services that the LEA is providing in schools not receiving Title I, Part A, or Title I, Part C, (MEP) funds.</i></p>	<p><a href="#"><u>Title I, Part A FAQ</u></a></p> <p><a href="#"><u>Title I, Part C FAQ</u></a></p> <p><a href="#"><u>Title I, Part D FAQ</u></a></p>	TxSP has protocols and documents that address behavior supports, attendance programs, community/parent engagement, prevention for bullying and harassment, etc.

<p><b>Title IV, Part A:</b> Student Support and Academic Enrichment</p> <p>Title IV, Part A, Subpart 1, Student Support and Academic Enrichment grants are designed to improve the academic achievement of all students by increasing the capacity of LEAs, schools, and communities to:</p> <ol style="list-style-type: none"> <li>1. provide all students with access to a well-rounded education</li> <li>2. improve school conditions for student learning AND</li> <li>3. improve the use of technology to enhance students' academic outcomes and digital literacy.</li> </ol>	<p><i>The overarching goal of Title IV, Part A, is to increase the capacity of state education agencies, local educational agencies (LEAs), campuses, and communities to reach the following three goals:</i></p> <ol style="list-style-type: none"> <li>1. Provide all students access to a well-rounded education</li> <li>2. Improve academic outcomes by maintaining safe and healthy students</li> <li>3.
